CRISIS RESPONSE - MMC'S HIGHLY TRAINED STAFF PROVIDES COMPREHENSIVE WRAPAROUND SERVICES THAT MEET THE UNIQUE NEEDS OF EACH INDIVIDUAL OR HOUSEHOLD SERVICES THAT BEGIN WITH OUR 24/7 HELPLINE AND CRISIS DROP-IN CENTER. IN THE PAST YEAR ALONE, LAW ENFORCEMENT AGENCIES IN THE COUNTY RESPONDED TO 13,348 DOMESTIC VIOLENCE CALLS - AN 18% INCREASE FROM THE PREVIOUS YEAR AND A STAGGERING 61% RISE OVER THE PAST TWO YEARS. ALARMINGLY, THE SEVERITY OF REPORTED PHYSICAL ABUSE RESULTING IN INJURY IS ALSO ON THE RISE.

HOUSING SERVICES: MMC OPERATES SEVERAL HOUSING PROGRAMS THAT PROVIDE CRITICAL, SAFE, AND CONFIDENTIAL SHELTER AND ONGOING SUPPORT SERVICES TO SURVIVORS AND THEIR CHILDREN RECOVERING FROM VIOLENCE. IN ADDITION TO THE EMERGENCY SHELTER, MMC'S HOUSING PROGRAMS ALSO INCLUDE FACILITY AND COMMUNITY BASED LONGER-TERM TRANSITIONAL SHELTER AS WELL AS OFF-SITE SHORT-TERM RENTAL ASSISTANCE PROGRAMS FOR PERMANENT HOUSING. CLIENTS MAY PARTICIPATE IN THESE PROGRAMS FOR A PERIOD OF BETWEEN 12 AND 24 MONTHS DEPENDING ON THEIR UNIQUE NEEDS. MMC USES THE HOUSING FIRST MODEL, WHICH USES HOUSING AS A TOOL FOR RECOVERY RATHER THAN A REWARD FOR PARTICIPATION AND FOCUSES ON CONNECTING SURVIVORS TO PERMANENT HOUSING AS QUICKLY AS POSSIBLE. THE RENTAL ASSISTANCE PROGRAM IS AN IDEAL CHOICE FOR DOMESTIC VIOLENCE SURVIVORS SEEKING HOUSING
